

## Robert W. Vaughan Athletic Center Rules and Policies

Management has tried to limit these rules and policies to the minimum required for the mutual enjoyment of its members and their guests. The enforcement of these rules and policies is for the good of all members to assure the comforts and service to which each member of *Vaughan Athletic Center (VAC)* is entitled. Management shall have the right to suspend or withdraw center privileges from any member, who in their opinion, has abused prescribed privileges or conducted himself or herself in a manner detrimental to *Fox Valley Park District (FVPD)*, the *VAC* or its members. There will be no refund of the enrollment fee or unused dues. The manager or designee shall have complete charge of the center while on duty. If you have any questions or concerns, please ask for the manager on duty or contact the membership department. *The Fox Valley Park District* shall not be held responsible or liable by any member or guest for personal injury damage or loss of personal property for any reason. Anyone using *FVPD* facilities does so at their own risk.

**PAYMENT OF DUES** – Past due membership dues (i.e. rejected or expired credit cards, accounts with insufficient funds) are subject to a \$25.00 charge. Any member whose account remains unpaid 60 days after the date billed will have their membership privileges terminated and will be sent to our collection agency for payment of the full amount owed per the agreement.

**MEMBER HEALTH WARRANTY** – Member warrants and represents that he/she has no disability, impairment or ailment that will prevent him/her from engaging in active or passive exercise or that will be detrimental to his/her health, safety or physical condition if he/she does participate. Member assumes any risks normally associated with the use of health, fitness and spa facilities and the participation in activities or programs conducted at the *VAC*. This representation and warranty is made by member knowing that *Fox Valley Park District* will rely upon the same in connection with the sale of membership.

**CENTER HOURS** – The center hours are subject to change without notice. Management reserves the right to close the *Vaughan Athletic Center* from time to time to facilitate center programs, certain holidays and any scheduled or unscheduled aspects of maintenance.

**MEMBERSHIP CARDS** – A membership card will be issued to all members. The card is not transferable and must be presented to the front desk upon entering each activity area of the *Vaughan Athletic Center*. A fee will be charged for replacement of lost membership cards. Membership cards must be returned upon cancellation of membership.

**PARENTAL PRESENCE** – Parents must be on the premises in order to leave their children in the childcare area. Children under the age of 11 cannot be left unattended without adult supervision from a parent or legal guardian at any time, unless participating in a facility program.

**DAILY FEE GUESTS** – All guests are required to pay a guest fee for each visit, register at the front desk and show a current form of photo identification.

**LOCKERS** – *Vaughan Athletic Center* provides various dressing rooms and locker rooms with free daily use lockers for members and their guests, but we suggest you keep articles of value with you. We are not responsible for any theft or loss on the premises. Management will remove all clothing and equipment left in the lockers overnight.

**VALUABLE AND PERSONAL PROPERTY** – *Fox Valley Park District*, its affiliates, agents or employees, shall not be liable for the loss, or theft, or damage of personal property of members or guests.

**PETS** – Pets are not allowed at the *Vaughan Athletic Center*. Special accommodations for guide dogs are to be made with management.

**NO SMOKING PERMITTED** – Smoking of any kind is not permitted in the *Vaughan Athletic Center*.

**DRINKS AND FOOD** – Drinks and food are only allowed in the restaurant or lounge areas. Water is allowed in some areas and should be stored in capped or covered containers.

**NO ALCOHOLIC BEVERAGES OR ILLICIT DRUGS** – No alcoholic beverages and/or illicit drugs of any kind may be brought into *Vaughan Athletic Center*. Violation of this rule will result in immediate expulsion.

**PROPER ATTIRE** – Proper shirts and shoes must be worn in all areas except in pool areas and locker rooms. Only white-soled athletic shoes that do not mark the floors are allowed on the exercise and court floors. Please refer to posted area rules & policies for details.

Be considerate of others, **loud or abusive language** will **NOT** be tolerated.

Members using MP3, radio, tape or CD players must use headphones.

Towels, toiletries, and other center property, are provided by *Vaughan Athletic Center* as a courtesy to its members during center usage only. Removal of center property from the premises may result in the termination of membership privileges.

By signing the application the member understands and agrees that he/she waives the right and right of their heirs, administrators, executors, successors and assigns to all claims arising out of the use of the premises and the membership, including but not limited to personal injury, including bodily injury and death, and all property damage, loss or theft.
